Once again a motion was made by **Robert Schuh** stating "Members assigned to a dock space must have a white number sticker (LPPOA) attached to the boat, on dock side, near the MC# visible to see and mail a current copy of boat registration to LPPOA, if NOT you will lose your dock space." This motion was seconded by **Lee Ferguson.** All in favor.

Dennis also suggested that we amend the bylaw with the above provision and place it in the Dock Section of our bylaws for all to read.

At this point in the meeting Rodney Bentz pulled a winning ticket and congratulation to Richard Sislo with the winning ticket and a gift certificate to Home Depot.

New Business

Lee took the floor again and discussion was had concerning the scholarship for Charlton Heston Academy. Lee reported that the LPPOA Board voted <u>not</u> to issue a scholarship this year. He further explained that we have a lot of expenses ahead for our association. There was much discussion on this decision but the funds just are not there.

Lee Ferguson went into detail on the limestone needed once again on the walkway. Last time it cost \$4833.00 and we will keep it under \$5000.00 once again this year. Also up for discussion was the rocks that is needed at the north end. They need to be freshened up. Once again discussion and prices were estimated at about \$1000.00. **Dennis Dusseau** made a motion to keep the cost at no more than \$1000.00 and it was seconded by **Mr. Clark.** All in favor.

Once again, Rodney pulled another ticket and congratulation to Phil Abdoo with the winning ticket and a gift certificate to Home Depot.

The next thing on the agenda is election of officers.

At this point, Lee asked for more volunteers and asked Martin Cameron if he would like to help as trustee as dock chairman's are not on the board. He agreed.

Trustee Pamela Armstrong elected Motion: Connie Balagna Second: Mike Rajter

All were in favor of each nomination.

Rodney Bentz was at it again and drew the another winning ticket. It went to Jan Muck to spend at Subway.

The last drawing was our 50/50 drawing and it went to Kevin Misch. He won \$135.00

Before this meeting ended Joe Lumetta wanted the floor to explain his problem with his dock and surrounding area. After much discussion it was decided that we accept Joe's request to keep his dock on the shoreline at his dock location during the winter months and he is to flag it in a manner that can be easily seen by anyone operating a snowmobile or ATV. The marker (s) must be installed so that they will not be blown off or accidentally removed and he is responsible for anything that happens as a result of his dock storage. The dock sections are not to be left on the LPPOA parkway. A hand vote was taken and majority in favor.
